

In accordance with section 24 of the Residential Tenancy Act 2010, it is hereby acknowledged that the reservation fee referred to in this application for tenancy form is subject to the following condition:

- 1. The applicant is required to pay a holding fee equivalent to one week's rent to reserve the premises in favour of the applicant for a period of one week.
- 2. The property will not be let during the reservation period pending the making of a Residential Tenancy Agreement.
- 3. If the landlord decides not to enter into the Residential Tenancy Agreement on the agreed terms for the residential premises concerned during the reservation period, the whole of the fee should be refunded.
- 4. Should the applicant advise they will not be going ahead then the owner may keep the whole of the holding fee.
- 5. During the reservation period, no fee will be taken from another applicant nor will the premises be reserved to another's favour.
